Azerbaijan Journal of Ophthalmology is a peer-reviewed open-access periodical that publishes original articles reflecting the results of both local and foreign scientists on current problems in ophthalmology and related sciences. The journal has been published quarterly in both print and electronic formats by the National Ophthalmology Centre named after Academician Zarifa Aliyeva since 2009 (www.oftalmologiya.az). The journal is included in the list of publications approved by the Supreme Attestation Commission of the Republic of Azerbaijan and is intended for professor, faculty, researchers, and individuals pursuing scientific degrees. The journal has been assigned an international ISSN codes (ISSN print: 2220-7910; ISSN online: 2709-4634) and is registered in the CROSSREF, RSCI, and ROAD databases. The journal's editorial board publishes articles in the order of discussion, and they may not necessarily agree with the authors' opinions. The authors are responsible for the reliability of the data, adherence to the ethical research standards in accordance with the Declaration of Helsinki, and the absence of conflicts of interest. The editorial board is not responsible for the content of advertising materials.

The submitted article must be original. Articles previously published or simultaneously submitted for review to other journals will not be accepted. An author may submit a published portion of their dissertation as a manuscript, provided that this manuscript is only a part of the dissertation and not presented as a component of another journal article. If the presence of plagiarized content or duplication resulting from the use of generative artificial intelligence technology is detected, the article will not be reviewed. When using figures, photos, or tables from other publications, written permission for republication from the authors of those materials is required and must be submitted to the editorial board.

All accepted articles for publication are assigned a unique, permanent digital object identifier (DOI).

Only articles prepared in accordance with the guidelines specified for authors will be accepted for publication. All manuscripts must include page and line numbers.

### 1. SUMMARY

Submitted abstracts must be prepared in both Azerbaijani and English:

The abstract should include the following information:

- Authors' surnames and initials of their first names;
- Article title (should be in all capital letters and not exceed 150 characters);
- Full name and address of the author's or authors' affiliated organization.

The abstract should not exceed 250 words and must follow this structure:

Purpose, Material and Methods, Results, Conclusion, Keywords. The text should be formatted in Times New Roman font, size 11, with single line spacing. Abbreviations used for the first time in the abstract must be clearly explained, and no references should be included.

#### 2. MAIN TEXT OF THE ARTICLE

The main text of the article should be presented in Azerbaijani or English and should consist of the following:

- Relevance of the study (a brief introduction reflecting the current state of the issue)
- Purpose (in accordance with the article's title)
- Material and Methods
- Results (with consecutively numbered tables and figures)
- Discussion (the obtained results should be compared with recent studies in modern literature, and a conclusion should be drawn regarding the significance and novelty of the presented work)
- Conclusion by points or a brief summary

The text should be formatted in Times New Roman, font size 12, with a line spacing of 1.15. Page margins should be set as follows: top and bottom - 2 cm, left - 3 cm, right - 1 cm. The text should be justified, with no hyphenation. The length of original articles, including abstract, tables, figures, and references, should not exceed 7-9 pages. Literature reviews should be between 10-15 pages, and clinical cases should be between 4-6 pages. Abbreviations, other than those commonly accepted, are not permitted. Specialized terms, other than abbreviations already mentioned in the abstract, must be spelled out in full when first mentioned. Tables and figures should be clear, concise, and visually informative. They must include a title, and the headings should accurately reflect the content. All figures and tables must correspond to those presented in the text and should be statistically processed. For accepted manuscripts, the minimum resolution for image files must be 300 dpi. In the text of the article, the

terms "Table" and "Figure" should be highlighted in bold. Graphs and tables should be presented in a format that allows for editing.

#### 3. REFERENCES

The reference list should be presented according to the order of citation in the article, not in alphabetical order. If the article contains multiple references to the same source, it is assigned the same reference number. All sources must be numbered, and the numbering must correspond precisely to the order in which they are cited in the text. The number of references should not exceed 10-20 for original articles and 50 for literature reviews. In the list of references, priority should be given to scholarly works published within the last 5-10 years. If a DOI (Digital Object Identifier) is available for a source, it must be indicated. The reference list is prepared in accordance with the requirements for dissertations set by the Supreme Attestation Commission of the Republic of Azerbaijan.

#### 4. ACKNOWLEDGMENTS

Acknowledgements should be written in the third person and addressed to non-author colleagues and researchers. Authors are responsible for obtaining permission from individuals mentioned in the Acknowledgements. Acknowledgements are not intended to recognize personal or manuscript support, and reviewers and editors should not be mentioned in them.
