The second page and further the article (*times new roman font, font size 12, interval 1,15, page parameters: upper and lower – 2 sm, left – 3 sm, right – 1 sm. The volume of the original articles, including summary, tables, figures should not exceed 7-9 pages, literature reviews – 10-15 pages, clinical cases – 4-6 pages. The tables, pictures and diagrams must be clear, compact, visual, have a name, headlines must exactly match their content. All numbers in the tables must exactly match the numbers in the text and be processed statistically. Abbreviations, except generally accepted, are not allowed. The conventions of special terms at the first mention fully. It is forbidden to publish any information that allows identification. Substantiation of work (brief introduction, reflecting the status of the issue)*).

References / the list of literature at the end of article is given not in alphabetical order, but in the sequence in which the sources are presented in the article. If the article has a repeated reference to a literary source, it is given the same number. All sources should be numbered and their numbering should strictly correspond to the numbering in the text. The number of literary source

used should not exceed 10-20 for original articles and 50 for literary reviews. When referring to dissertation abstracts, their name should be indicated. In the list of literature preference should be given to scientific papers published over the past 5-10 years.
